APPROVING MUNICIPAL RESOLUTION NO. 2020-121 OF THE SANGGUNANG BAYAN OF ALCALA, PANGASINAN, ENTITLED "APPROVING THE SUPPLEMENTAL ANNUAL INVESTMENT PROGRAM NO. 01 FOR CALENDAR YEAR 2020 OF THE MUNICIPALITY OF ALCALA, PANGASINAN"

WHEREAS, the Sangguniang Bayan of Alcala, Pangasinan submitted its Municipal Resolution No. 2020-121 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Provincial Planning and Development Officer, have conducted initial review and study on said resolution and found out that the Local Development Council of Alcala, Pangasinan had identified items in their Supplemental Annual Investment Program No. 01 for CY 2020. This was endorsed to the Sangguniang Bayan for approval through MDC Executive Committee Resolution No. Resolution No. 2020-01 dated March 17, 2020 and was favorably acted upon by the Sangguniang Bayan on March 30, 2020 through Resolution No. 2020-121;

WHEREAS, the Supplemental Investment Program No. 01 of the municipality with an investment requirement amounting to P6,193,434.43 covers the following: the implementation of salary increase and terminal leave benefits of municipal officials and employees (P1,642,185.34 which is supported by Supplemental Budget No.1) and programs/projects to address the crisis brought by COVID-19 pandemic to be funded from the Trust Fund QRF CYs 2019 (P2,374,590.38) and 2020 (P2,176,647.81);
