**APPROVING IN PART RESOLUTION NO. 47, S-2021 OF THE SANGGUNIANG BAYAN OF INFANTA, PANGASINAN, ENTITLED “APPROVING THE FIRST SUPPLEMENTAL ANNUAL INVESTMENT PROGRAM (AIP) FOR CALENDAR YEAR 2021 OF THE MUNICIPALITY OF INFANTA, PANGASINAN”, EXCEPT THE PROGRAMS, PROJECTS AND ACTIVITIES TO BE FUNDED BY THE UNEXPENDED LDRRMF IN THE AMOUNT OF P 2,868,497,54.**

**WHEREAS**, the Sangguniang Bayan of Infanta, Pangasinan submitted its SB Resolution No. 47, S-2021 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

**WHEREAS**, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Planning and Development Officer have conducted initial review and study on said SP Resolution and found out that the subject resolution is in consonance to Sections 106, 109 and 114 of R.A. No. 7160;

**WHEREAS**, Local Development Council of Infanta, Pangasinan had identified items in their First Supplemental Investment Program No. 1 for CY 2021. This was endorsed to the Sangguniang Bayan of Infanta on May 14, 2021 through MDC Resolution No. 1, Series of 2021;

**WHEREAS**, said Supplemental AIP covers the fund augmentation for the Personal Services of some municipal offices and development projects to be funded by Supplemental Budget No. 1, CY 2021 in the amount of P5,246,891.92 which was enacted by the Sangguniang Bayan on May 24, 2021 through Appropriation Ordinance No. 01, Series of 2021;

**WHEREAS**, this Supplemental AIP also includes the implementation of projects proposed to be funded from the Eramen Minerals, Inc. as their Corporate Social Responsibility amounting to P3,550,714.00, and disaster risk reduction and management projects of the municipality proposed to be funded from the National Disaster Risk Reduction and Management Fund under FY 2020 General Appropriations Act (GAA), RA No. 11465 in the amount of P279,075.00, and Local Government Support Fund-Disaster Rehabilitation and Reconstruction Assistance Program FY 2021 GAA, RA No. 11518 amounting to P6,275,700.00;

**WHEREAS**, disaster risk reduction and management programs and projects embodied in the SIP with the total amount of P2,868,497.54, which are proposed to be funded from the unexpended balances of 5% Local Disaster Risk Reduction and Management Fund FYs 2018-2019 may be released and utilized for new expenditure items only upon submission of a Revised AIP as approved by the local Sanggunian and Local Chief Executive upon recommendation of the LDRRMC in accordance with the approved LDRRMP pursuant to item 6.5 of the NDRRMC-DBM-DILG Joint Memorandum Circular No. 2013-1, dated March 25, 2013;

**WHEREAS**, the Sangguniang Panlawigan, after final evaluation, finds the subject resolution in order, however, compliance with all the existing laws, rules and regulations shall be the responsibility of the Municipal Government of Infanta, Pangasinan;

**WHEREFORE**, in view of the foregoing, on motion of SP Members Donabel N. Fontelera and Margielou Orange D. Humilde-Verzosa and co-sponsored by SP Members Sheila Marie S. Perez-Galicia, Jerome Vic O. Espino and Jeanne Jinky C. Zaplan, duly seconded, it was –
