APPROVING RESOLUTION NO. 21-042 OF THE PANLUNGSOD OF CARLOS, SANGGUNIANG SAN "APPROVING PANGASINAN, ENTITLED SUPPLEMENTAL INVESTMENT PROGRAM (SIP) NO. 2 FOR CALENDAR YEAR 2021 OF THE CITY OF SAN CARLOS, PROVINCE OF PANGASINAN"

WHEREAS, the Sangguniang Panlungsod of San Carlos, Pangasinan submitted its SP Resolution No. 21-042 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Planning and Development Officer have conducted initial review and study on said SP Resolution and found out that the City Development Council-Executive Committee of San Carlos City, Pangasinan prepared the city's Supplemental Annual Investment Program No. 2 for CY 2021 and endorsed to the Sangguniang Panlungsod through CDC Resolution No.04-21 (Series of 2021) dated April 13, 2021;

WHEREAS, said Supplemental AIP with an investment requirement of P10,296,597.42, covers items for Personal Services, mainly for the salary increase of officials and employees of the City Government of San Carlos;

WHEREAS, funding support for the implementation of the Supplemental AIP is embodied in the Supplemental Budget No. 01-21, CY 2021 of the LGU, which was approved by the Sangguniang Panlungsod through Appropriation Ordinance No. 21-05 dated April 26, 2021;
