## **RESOLUTION NO. 582-2019**

DECLARING ORDINANCE NO. 110, S-2019 OF THE SANGGUNIANG BAYAN OF BASISTA, PANGASINAN, ENTITLED "AN ORDINANCE PROHIBITING THE USE OF SINGLE-USE PLASTIC CELLOPHANE AND SANDO BAGS AS PACKAGING MATERIALS AND UTILIZATION OF POLYSTYRENE, COMMONLY KNOWN AS STYROFOAM, FOR GOODS, FOOD AND BEVERAGES CONTAINERS IN THE MUNICIPALITY OF BASISTA AND PRESCRIBING PENALTIES THEREOF" AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIANG BAYAN TO ENACT

**WHEREAS**, the Sangguniang Bayan of Basista, Pangasinan submitted its Ordinance No. 110, Series of 2019 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

**WHEREAS**, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Provincial Legal Officer, have conducted initial review and study on said ordinance and found out that the same was enacted pursuant to Section 16, 447 (a) (iii), (5) (xiii) of RA 7160;

WHEREAS, subject ordinance shall take effect after the requirements of posting and publication are complied with by the Sangguniang Bayan pursuant to Section 59 (c) and 511 (a) of RA 7160;
