DECLARING MUNICIPAL ORDINANCE NO. 136-120121 OF THE SANGGUNIANG BAYAN OF VILLASIS, PANGASINAN, ENTITLED "AN ORDINANCE PROHIBITING ALL FORMS OF ILLEGAL GAMBLING IN THE MUNICIPALITY OF VILLASIS, PANGASINAN" AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIANG BAYAN TO ENACT

**WHEREAS**, the Sangguniang Bayan of Villasis, Pangasinan submitted its Municipal Ordinance No. 136-120121 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Legal Officer, have conducted initial review and study on said municipal ordinance and found out that the same was enacted pursuant to Sections 447 (a) (1) (v) and (4) (vii) of RA 7160 and Section 11 (b) (3) of R.AS. No. 10121 otherwise known as the Philippine Disaster Risk Reduction and Management Act of 2010;

WHEREAS, subject ordinance shall take effect after the requirement of publication pursuant to Section 511 (a) of RA 7160 is complied with;
