APPROVING RESOLUTION NO. 45, S-2019 OF THE SANGGUNIANG BAYAN OF CALASIAO, PANGASINAN, ENTITLED "APPROVING THE SUPPLEMENTAL ANNUAL INVESTMENT PROGRAM (AIP) OF THE MUNICIPALITY OF CALASIAO FOR THE YEAR 2019"

WHEREAS, the Sangguniang Bayan of Calasiao, Pangasinan submitted its Resolution No. 45, Series of 2019 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Provincial Planning and Development Officer, have conducted initial review and study on said resolution and found out that the Municipal Development Council – Executive Committee of Calasiao, Pangasinan has prepared the municipality's Supplemental Annual Investment Program for CY 2019. This was endorsed by the Council, thru MDC Resolution No. 03, S-2019 dated July 15, 2019 to the Sangguniang Bayan for approval. The Sangguniang Bayan approved said endorsement through Sangguniang Bayan Resolution No. 45, S-2019 dated July 29, 2019;

WHEREAS, said Supplemental Annual Investment Program, which has a total investment requirement of P6,151,082.47. Said Supplemental AIP covers augmentation funds for Personal Services, MOOE and Capital Outlay of the LGU, DRRM and GAD-related projects and activities;
