DECLARING ORDINANCE NO. 19-10 OF THE SANGGUNIANG PANLUNGSOD OF SAN CARLOS, PANGASINAN, ENTITLED "AN ORDINANCE PROVIDING FOR SAN CARLOS CITY (PANGASINAN) POLICIES ON RESPONSIBLE PARENTHOOD AND REPRODUCTIVE HEALTH" AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIANG BAYAN TO ENACT

WHEREAS, the Sangguniang Panlungsod of San Carlos, Pangasinan submitted its Ordinance No. 19-10 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Provincial Legal Officer, have conducted initial review and study on said ordinance and found out that the same was enacted pursuant to Section 16 of RA 7160; RA No. 10354, otherwise known as "Responsible Parenthood Reproductive Health Act of 2012";

WHEREAS, subject ordinance shall take effect after the requirements of posting and publication are complied with by the Sangguniang Panlungsod pursuant to Section 59 (c) and 511 (a) of RA 7160;
