PROVINCIAL RESOLUTION NO. 586-2021

URGING THE DEPARTMENT OF HEALTH CENTER FOR HEALTH DEVELOPMENT-I TO INSTITUTE RIGOROUS VERIFICATION, REVIEW AND SCRUTINY ON THE LIST OF RECIPIENTS AND MANNER OF DISTRIBUTION OF THE SPECIAL RISK ALLOWANCE (SRA) FOR THE PROVINCE OF PANGASINAN PARTICULARLY BARANGAY HEALTH WORKERS

WHEREAS, Special Risk Allowances are granted to public and private health workers who continue to do their jobs in order to help contain the pandemic and aid those who are affected by COVID-19;

WHEREAS, public health workers are exposed to the threat of COVID-19 and as a form of support by the national government through the Department of Health, Special Risk Allowances are granted to them including barangay health workers;

WHEREAS, barangay health workers are indispensable partners of the local government units in the promotion of basic health programs, projects and activities particularly in the barangays;

WHEREAS, during this period of pandemic, barangay health workers are also in the frontline service helping to contain the spread of Covid-19 virus;

WHEREAS, in recognition of their invaluable services to their respective communities, all barangay health workers who are actively and regularly performing their duties shall be included in the list of beneficiaries and be entitled to their incentives and benefits:

WHEREAS, it is important to institutionalize and strengthen primary health care at the barangay level by establishing the necessary support mechanisms and upgrading the incentives and benefits of barangay health workers;



NOW, THEREFORE, on motion of SP Member Jeremy Agerico B. Rosario, duly seconded, it was –


