APPROVING RESOLUTION NO. 25, S-2019 OF THE SANGGUNIANG BAYAN OF SAN FABIAN, PANGASINAN, ENTITLED “APPROVING THE SUPPLEMENTAL ANNUAL INVESTMENT PLAN NO. 3 FOR CY 2019 OF THE LOCAL GOVERNMENT OF SAN FABIAN, PANGASINAN IN THE AMOUNT OF P1,882,873.66”

WHEREAS, the Sangguniang Bayan of San Fabian, Pangasinan submitted its Resolution No. 25, Series of 2019 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Provincial Planning and Development Officer, have conducted initial review and study on said resolution and found out that the Municipal Development Council of San Fabian, Pangasinan has prepared the municipality’s Supplemental Annual Investment Program No. 3 for CY 2019. This was endorsed by the Council, thru MDC Resolution No. 04, S-2019 dated June 3, 2019 to the Sangguniang Bayan for approval. The Sangguniang Bayan approved said endorsement through Sangguniang Bayan Resolution No. 25, S-2019 dated August 14, 2019;

WHEREAS, said Supplemental Investment Program, which has a total funding requirement of P1,882,873.66 covers augmentation fund for MOOE of the LGU for the following projects: rehabilitation of the municipal park plaza lightings, rehabilitation of multi-purpose covered court at Barangay Alacan and janitorial/general services, and OSCA/PDAO activities. Portion of said amount is allocated to the 5% LDRRM Fund and 5% GAD projects/activities;


