RESOLUTION NO. 589-2020

APPROVING RESOLUTION NO. 2020-14 OF THE SANGGUNIANG BAYAN OF BOLINAO, PANGASINAN, ENTITLED “TO ADOPT THE DETAILS OF THE SUPPLEMENTAL INVESTMENT PROGRAM NO. 1 CY 2020 AS EMBODIED IN THE MDC RESOLUTION NUMBER 1, SERIES OF 2020 OF THE MUNICIPAL DEVELOPMENT COUNCIL OF BOLINAO, PANGASINAN”

WHEREAS, the Sangguniang Bayan of Bolinao, Pangasinan submitted its Resolution No. 2020-14 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Provincial Planning and Development Officer, have conducted initial review and study on said resolution and found out that the same is in consonance to Sections 106, 109, 114 of RA 7160. The Local Development Council of Bolinao, Pangasinan had identified items in their Supplemental Investment Program No. 1 for CY 2020. This was endorsed to the Sangguniang Bayan for approval on March 28, 2020 by the Municipal Development Council thru MDC Resolution No. 1-A, S-2020 and was favorably acted upon by the Sangguniang Bayan on March 31, 2020 thru SB Resolution No. 2020-14;

WHEREAS, the said Supplemental Investment Program with an investment requirement of P17,883,130.90 covers fund augmentation for the Personal Services, Maintenance and Other Operating Expenses and Capital Outlay of municipal offices, gender and development programs, disaster risk reduction programs, which is supported by Supplemental Budget No. 1 for Calendar Year 2020, which was passed and approved by their Sangguniang Bayan on March 31, 2020 thru Appropriation Ordinance No. 2020-01;
