**RESOLUTION NO. 593-2019**

**DECLARING ORDINANCE NO. 27, S-2016-19 OF THE SANGGUNIANG PANLUNGSOD OF URDANETA, PANGASINAN, ENTITLED "AN ORDINANCE RECLASSIFYING A TOTAL OF FORTY NINE THOUSAND SIX HUNDRED TEN (49,610) SQUARE METERS OF LAND AT THE FOREST LAKE MEMORIAL PARK PHASE 2 PROJECT IN BARANGAY PINMALUDPOD, COVERED BY TCT NOS. 299249, 232941, 180498, 272171, AND 232940 FROM AGRICULTURAL TO INSTITUTIONAL USE" AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIANG PANLUNGSOD TO ENACT**

**WHEREAS**, the Sangguniang Panlungsod of Urdaneta, Pangasinan submitted its Ordinance No. 27, S-2016-19 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

**WHEREAS**, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Provincial Legal Officer and the Provincial Planning and Development, have conducted initial review and study on said ordinance and found out that the same was enacted pursuant to Section 20 of RA 7160;

**WHEREAS**, the City of Urdaneta has an approved Zoning Ordinance implementing its Comprehensive Land Use Plan CY 2016-2025;

**WHEREAS**, however, a Clearance for Reclassification from the Department of Agriculture indicating that the subject area are not classified as non-negotiable for conversion or reclassification under Administrative Order No. 20 (1992) and that the land ceases to be economically feasible and sound for agricultural purposes; and Clearance for Reclassification from the Department of Agrarian Reform indicating that such lands are not distributed or not covered by a notice of coverage or not voluntarily offered for coverage under CARP;

**WHEREFORE**, in view of the foregoing, on motion of SP Members Rosary Gracia P. Perez-Tababa and Clemente B. Arboleda, Jr. and co-sponsored by SP Members Sheila Marie S. Perez-Galicia, Jerome Vic O. Espino and Arth Bryan C. Celeste, duly seconded, it was –


**RESOLVED**, by the Sangguniang Panlalawigan in session assembled, to declare Ordinance No. 27, S-2016-19 of the Sangguniang Panlungsod of **Urdaneta**, Pangasinan, entitled “An Ordinance reclassifying a total of Forty Nine Thousand Six Hundred Ten (49,610) square meters of land at the Forest Lake Memorial Park Phase 2 Project in Barangay Pinmaludpod, covered by TCT Nos. 299249, 232941, 180498, 272171, and 232940 from agricultural to institutional use” as within the conferred powers of the Sangguniang Panlungsod to enact;
