MOYA, PROVINCIAL AGRICULTURIST; MAYOR CEZAR T. QUIAMBAO OF BAYAMBANG, PANGASINAN; AND MR. ARTEMIO BUEZON, OIC-MUNICIPAL AGRICULTURIST OF THE SAID MUNICIPALITY, FOR ANOTHER QUESTION HOUR OF THE SANGGUNIANG PANLALAWIGAN DURING ITS OCTOBER 28, 2019 REGULAR SESSION TO UPDATE THE BODY ON THE STATUS OF AFRICAN SWINE FEVER, SPECIFICALLY IN THE MUNICIPALITY OF BAYAMBANG, PANGASINAN, IN AID OF LEGISLATION

Penuliar of Mapandan, Pangasinan; Atty. Geraldine U. Baniqued, Provincial Legal Officer; Dr. Jovito G. Tabarejos, Acting Provincial Veterinarian; and Mr. Rhodyn Luchinvar O. Oro, Provincial Disaster Risk Reduction and Management Officer, to a Question Hour of the Sangguniang Panlalawigan on its October 7, 2019 Regular Session to apprise the Body on the status of African Swine Fever in the Province of Pangasinan and the possible mitigating measures to prevent the entry of the same, in aid of legislation;

WHEREAS, during the Question Hour last October 7, 2019 with the attendance of all invited key officials from different government agencies, the Body was thoroughly apprised of the African Swine Fever (ASF) situation in the Province with the assurance from the Department of Agriculture that they will try their best to prevent the spread of the ASF virus in the Province;

WHEREAS, however, the Sangguniang Panlalawigan has been alarmed again of another alleged reported case of ASF virus at Barangay Apalen, Bayambang, Pangasinan last October 14, 2019;

WHEREAS, the Sangguniang Panlalawigan opted to invite again Dr. Jovito G. Tabarejos, Acting Provincial Veterinarian; Col. Rhodyn Luchinvar O. Oro, Provincial Disaster Risk Reduction and Management Officer; together with Mrs. Dalisay A. Moya, Provincial Agriculturist; Mayor Cezar T. Quiambao of Bayambang, Pangasinan; and Mr. Artemio Buezon, OIC-Municipal Agriculturist of the said municipality, for the said purpose;
