RESOLUTION NO. 595-2021

DECLARING ORDINANCE NO. 2021-12 OF THE SANGGUNIANG PANLUNGSOD OF ALAMINOS, PANGASINAN, ENTITLED "AN ORDINANCE PROVIDING FOR THE CREATION OF BARANGAY EMPLOYMENT SERVICE OFFICE IN EVERY BARANGAY WITHIN THE TERRITORIAL JURISDICTION OF THE CITY OF ALAMINOS, PANGASINAN" AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIANG PANLUNGSOD TO ENACT

WHEREAS, the Sangguniang Panlungsod of Alaminos, Pangasinan submitted its Ordinance No. 2021-12 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Legal Officer, have conducted initial review and study on said ordinance and found out that the same is consistent with Republic Act No. 8759 otherwise known as the "Public Employment Service Office Act of 1999" and the same is in conformity with Republic Act No. 10691, or the "Expanded PESO Law;
