Valencia of Labrador, Pangasinan for Violation of Paragraph (d) of the Local Government Code of 1991 and which was referred to the Committee on Good Government and Accountability of Public Officers, Justice and Human Rights as SP Administrative Case No. 01-2018;

WHEREAS, the Sangguniang Panlalawigan is in receipt of a verified administrative complaint filed on November 22, 2018 by Alexander M. Rigonan, Sr., Sally S. Del Ocampo, Rogelio A. Rico and Virgilio P. Caburao of Sual, Pangasinan for Grave Misconduct, Arbitrariness, and Conduct Prejudicial to the Best Interest of Service which was referred to the Committee on Good Government and Accountability of Public Officers, Justice and Human Rights as SP Administrative Case No. 04-2018;
