RESOLUTION S-2020**OF APPROVING** 23, SANGGUNIANG **BAYAN** OF BUGALLON, PANGASINAN, ENTITLED "APPROVING THE SUPPLEMENTAL INVESTMENT PROGRAM NO. 1 FOR FY 2020 OF THE MUNICIPALITY OF BUGALLON, PANGASINAN AMOUNTING TO TWENTY TWO MILLION NINE HUNDRED SEVENTY ONE THOUSAND ONE HUNDRED TWENTY EIGHT PESOS AND TWENTY EIGHT **CENTAVOS (P22,971,128.28)"** 

**WHEREAS**, the Sangguniang Bayan of Bugallon, Pangasinan submitted its Resolution No. 23, Series of 2020 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Provincial Planning and Development Officer, have conducted initial review and study on said resolution and found out that the same is in consonance to Sections 106, 109, 114 of RA 7160. The Local Development Council of Bugallon, Pangasinan had identified items in their Supplemental Investment Program No. 1 for CY 2020. This was endorsed to the Sangguniang Bayan for approval on March 31, 2020 by the Municipal Development Council thru Resolution No. 01, S-2020 and was favorably acted upon by the Sangguniang Bayan on March 31, 2020 thru SB Resolution No. 23, S-2020;

**WHEREAS**, the Supplemental Investment Program No. 1 of the municipality covers the fund augmentation for the personal services and maintenance and other operating expenses of municipal offices and the implementation of development projects and activities to address the crisis due to COVID-19 pandemic;
