APPROVING RESOLUTION NO. 43, S-2021 OF THE SANGGUNANG BAYAN OF SAN FABIAN, PANGASINAN, ENTITLED “APPROVING THE SUPPLEMENTAL ANNUAL INVESTMENT PROGRAM NO. 2 FOR CY 2021 OF THE MUNICIPALITY OF SAN FABIAN, PANGASINAN AMOUNTING TO FIVE MILLION PESOS FROM THE REALIGNMENT OF VARIOUS FUNDS”

WHEREAS, the Sangguniang Bayan of San Fabian, Pangasinan submitted its SB Resolution No. 43-2021 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Planning and Development Officer have conducted initial review and study on said SB Resolution and found out that the Municipal Development Council of San Fabian, Pangasinan prepared the Supplemental Annual Investment Program No. 2 for CY 2021. This was endorsed to the Sangguniang Bayan for approval on April 29, 2021 by the Municipal Development Council through MDC Resolution No. 02, S- 2021;
