THIS IS TO CERTIFY that at the regular session duly constituted of the Sangguniang Paalalawigan, Province of Pangasinan, held on June 11, 1990, at Lingayen, Pangasinan, the following Ordinance was approved:

PROVINCIAL ORDINANCE NO. 05-1990

ORBA INCISITIO PEDPED MARSO AND MAKOKOLI IN BARANGAY INMALOG.
UAN FABIAN, PANGASINAN, INTO A SEPARATE, DISTINCT AND INDEPENDENT
BARANGAY TO BE NAMED "BARANGAY INMALOG NORTE", OF THE MUNICIPALITY
OF SAN FABIAN, PANGASINAN

Deries of 1989 of the Sangguniang Bayan of San Fabian, Pangasinan favorably indorsing the petition of residents constituting majority of the registered voters of Sitios Pedped Marso and Makokoli in Barangay Inmalog, San Fabian, Pangasinan for the separation of both sitios, and for its creation as an independent and full-fledged barangay to be named as "Barangay Inmalog Norte";

WHEREAS, pursuant to the pertinent provisions of the New Local Government Code, in the creation of new barangay, all the essential requirements therein are satisfactorily met;

WARREAS; the residents and leaders therein are of the firm belief that the creation would hasten social, economic and political diplomats in the area and forter faster delivery of basic services;

MHEREFOLE, in view of the foregoing, on motion of SP Member Dionisic C. Antiniw, spontaneously seconded by all; it was -

RESOLVER, by the Sang uniang Panlalawigan in session assembled to crest as it is hereby created, Sitios Padpal Marso and Makokoli in Barangay Innal San Fabian, Fangasinan into a separate that inct and independent barangay to be named "Barangay Innalog Norte", if the Municipality of San Fabian, Tangasinan;

a plebisci in this new manages within forty five (45) days from approval of this ordinance and for the COMELEC to duly inform this Body of the holding of such plebiscite for its information and guidance;

RESOLVED, FURTHERMORE, that the Provincial Assessor in coordination with other agencies, determine the official boundaries of this newly created bar ingay for the official record and for the information of all concerned;

RESOLVED, FINALLY, that copies of this resolution be furnished the Frovincial Assessor, Provincial Treasurer, Provincial Auditor, Provincial Engineer, DLG, Bureau of Lands, FC-INF, COMELEO and DECS, for their information and guidance.
