DECLARING MUNICIPAL ORDINANCE NO. 03-06072021 OF THE SANGGUNIANG BAYAN OF POZORRUBIO, PANGASINAN, ENTITLED "AN ORDINANCE PROHIBITING ALL FORMS OF ILLEGAL GAMBLING IN THE MUNICIPALITY OF POZORRUBIO, PANGASINAN AND IMPOSING CHARGES ON VIOLATORS THEREOF" AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIANG BAYAN TO ENACT

WHEREAS, the Sangguniang Bayan of Pozorrubio, Pangasinan submitted its Municipal Ordinance No. 03-06072021 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, subject ordinance shall take effect after the requirements of posting and publication pursuant to Section 59 (c) and 511 (a) of RA 7160 are complied with;
