APPROVING RESOLUTION NO. 22. S-2020 OF THE SANGGUNIANG BAYAN OF VILLASIS, PANGASINAN, ENTITLED "APPROVING THE SUPPLEMENTAL ANNUAL INVESTMENT PROGRAM NO. 02 OF FISCAL YEAR 2020 FOR THE BAYANIHAN GRANT TO CITIES AND MUNICIPALITIES IN THE AMOUNT OF THIRTEEN MILLION EIGHT HUNDRED TWENTY FIVE THOUSAND FOUR HUNDRED FORTY TWO PESOS (P13,825,442.00) OF THE MUNICIPALITY OF VILLASIS, **PANGASINAN**"

WHEREAS, the Sangguniang Bayan of Villasis, Pangasinan submitted its Resolution No. 22, Series of 2020 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Provincial Planning and Development Officer, have conducted initial review and study on said resolution and found out that the same is in consonance to Sections 106, 109 and 114 of RA 7160. The Local Development Council of Villasis, Pangasinan has formulated, adopted and endorsed the municipality's Supplemental Annual Investment Program thru MDC Executive Committee Resolution No. 02-2020 dated April 17, 2020 to the Sangguniang Bayan for approval. This was approved by the Sangguniang Bayan on April 22, 2020 thru Resolution No. 22, S-2020;

WHEREAS, the Supplemental Annual Investment Program No. 02 of the municipality with an investment requirement of P13,825,442.00 covers programs/projects/activities to address emergency response measures to COVID-19 pandemic. This will be funded from Bayanihan Grant to Cities and Municipalities (BGCM) under RA 11469 (The Bayanihan to Heal as One Act);
