APPROVING RESOLUTION NO. 050-2021 OF THE SANGGUNIANG BAYAN OF LABRADOR, PANGASINAN, ENTITLED "APPROVING SUPPLEMENTAL ANNUAL INVESTMENT PROGRAM NO. 1 FOR CY 2021 OF THE MUNICIPALITY OF LABRADOR, PANGASINAN"

WHEREAS, the Sangguniang Bayan of Labrador, Pangasinan submitted its SB Resolution No. 050-2021 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Planning and Development Officer have conducted initial review and study on said SP Resolution and found out that the subject resolution is in consonance to Sections 106, 109 and 114 of R.A. No. 7160;

WHEREAS, the Local Development Council of Labrador, Pangasinan had identified items in their Supplemental Investment Program No. 1 for CY 2021, P9,278,320.00 which was endorsed to the Sangguniang Bayan for approval on June 18, 2021 through MDC Resolution No. 01-2021;

WHEREAS, said Supplemental AIP of the municipality covers the fund augmentation for the Maintenance and Other Operating Expenses and Capital Outlay of some municipal offices, programs and projects to address the impacts of COVID-19 and implementation of infrastructure projects of the municipality;

Funding support for the full implementation of the same is embodied in Supplemental Budget No. 1 for CY 2021 of the municipality which was approved and enacted by the Sangguniang Bayan of Labrador on June 21, 2021 through Appropriation Ordinance No. 01-2021 and approved by the Municipal Mayor on June 25, 2021;


