**APPROVING RESOLUTION NO. 2019-143 OF THE SANGGUNIANG BAYAN OF SISON, PANGASINAN, ENTITLED “APPROVING THE 1<sup>ST</sup> SUPPLEMENTAL ANNUAL INVESTMENT PROGRAM CY 2019 OF THE MUNICIPALITY OF SISON, PANGASINAN”**

**WHEREAS**, the Sangguniang Bayan of Sison, Pangasinan submitted its Resolution No. 2019-143 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

**WHEREAS**, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Provincial Planning and Development Officer, have conducted initial review and study on said resolution and found out that the Local Development Council of Sison, Pangasinan has formulated the municipality’s 1<sup>st</sup> Supplemental Investment Program for CY 2019 and endorsed thru MDC Resolution No. 03-2019 dated September 12, 2019 to the Sangguniang Bayan for approval. The Sangguniang Bayan approved the 1<sup>st</sup> Supplemental Investment Program on September 23, 2019 through Resolution No. 2019-143, S-2019. This is in pursuance to Sections 106, 109 and 114 of RA 7160;

**WHEREAS**, the 1<sup>st</sup> Supplemental Investment Program of Sison, Pangasinan covers the implementation of the 4<sup>th</sup> tranche salary increase, fund augmentation for MOOE and Capital Outlay of the executive and legislative department, implementation of disaster risk reduction and management projects and new development projects of the municipality to be funded from the tobacco excise tax and national government agencies;

**WHEREAS**, the 1<sup>st</sup> Supplemental Investment Program of the municipality has a total investment requirement amounting to P130,599,897.13, which will be sourced from the following:

- Supplemental Budget No. 1	-	P37,200,135.03
- 5% MDRRM Fund Savings (2013-2018)	-	10,909,620.12
- Savings from Tobacco Excise Tax Implemented projects 2011-2017	-	2,662,217.01
- Municipality's Share from CY 2016 Tobacco Excise Tax as per DBM LBM No. 79	-	10,844,925.00
- National Government Agencies (NGAs)	-	68,983,000.00

**WHEREAS**, the projects to be funded by the Tobacco Excise Tax conforms with Local Budget Memorandum No. 79 dated June 14, 2019 (*Guidelines on the Release and Utilization of the Shares of Local Government Units from the FY 2016 Collections of Excise Tax on Locally Manufactured Virginia-Typed Cigarettes under Republic Act (RA) No. 7171 and Burley and Native Tobacco Excise Tax pursuant to RA No. 8240, as amended by RA No. 10351, chargeable against the Allocation of Local Government Units under the FY 2018 General Appropriations Act, Republic Act No. 10964, Continuing Appropriations*);

**WHEREAS**, the 1<sup>st</sup> Supplemental Investment Program of the municipality which is the subject of the resolution may be considered favorably in part except for the implementation of the disaster risk reduction and management projects to be funded from the MDRRMF Trust Fund (2013-2018) which is subject to compliance to Item Nos. 6.4 and 6.5 of the NDCC-DBM-DILG-JMC No. 2013-1 dated March 25, 2013;

**WHEREFORE**, in view of the foregoing, on motion of SP Members Rosary Gracia P. Perez-Tababa and Nicholi Jan Louie Q. Sison and co-sponsored by SP Members Sheila Marie S. Perez-Galicia, Jerome Vic O. Espino and Jose G. Peralta, Jr., duly seconded, it was –


