PROVINCIAL RESOLUTION NO. 62-2021

REQUESTING FOR THE SETTING UP OF A VACCINE ROLLOUT PLAN IN THE PROVINCE OF PANGASINAN

WHEREAS, Section 16 of the Local Government Code empowers local government units to exercise the powers which are essential to the promotion of the general welfare, health and safety within their respective territorial jurisdiction;

WHEREAS, with the availability of vaccine supply in the market, it is high time for the Province to concretize its COVID-19 vaccination program;

WHEREAS, several local government units in the country have already earmarked a sizeable amount of their funds for the purchase of vaccines;

WHEREAS, priority groups for the initial roll out of the vaccines should now be identified and all logistical and other requirements should be addressed since the procurement process in the country is nearing its completion and eventually the Province can avail of the same;

WHEREAS, the Sangguniang Panlalawigan fully supports any undertaking that could strengthen the strategies of the Province in the implementation of the vaccination program;

WHEREFORE, in view of the foregoing, on motion of SP Member Von Mark R. Mendoza, duly seconded, it was –

RESOLVED, by the Sangguniang Panlalawigan in session assembled to request, as it is hereby requested, for the setting up of a vaccine rollout plan in the Province of Pangasinan;


