APPROVING RESOLUTION NO. 20-035 OF THE SANGGUNIANG BAYAN OF LAOAC, PANGASINAN, ENTITLED "APPROVING THE SUPPLEMENTAL ANNUAL INVESTMENT PROGRAM (AIP) NO. 3 FOR CALENDAR YEAR 2020 OF THE MUNICIPALITY OF LAOAC, PANGASINAN IN THE TOTAL AMOUNT OF EIGHT MILLION FIVE HUNDRED FORTY SEVEN THOUSAND SEVEN HUNDRED FORTY ONE PESOS ONLY (P8,547,741.00) FOR THE BAYANIHAN GRANT TO CITIES AND MUNICIPALITIES (BGCM) PURSUANT TO RA NO. 11469, AS REVISED"

**WHEREAS**, the Sangguniang Bayan of Laoac, Pangasinan submitted its Resolution No. 20-035 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991:

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Provincial Planning and Development Officer, have conducted initial review and study on said resolution and found out that the same is in consonance to Sections 106, 109 and 114 of RA 7160. The Local Development Council of Laoac, Pangasinan has formulated, adopted and endorsed the municipality's Supplemental Annual Investment Program No. 3 thru MDC Resolution No. 2020-03 dated May 20, 2020 to the Sangguniang Bayan for approval. This was approved by the Sangguniang Bayan on June 8, 2020 thru Resolution No. 20-035;

**WHEREAS**, the Supplemental Annual Investment Program No. 3 of the municipality has an investment requirement of P8,547,741.00 which covers programs/projects/activities to address emergency response measures to COVID-19 pandemic. This will be funded from Bayanihan Grant to Cities and Municipalities (BGCM) under RA 11469 (The Bayanihan to Heal as One Act);
