PROVINCIAL RESOLUTION NO. 621-2021

APPEALING FOR THE SUSPENSION OF THE IMPLEMENTATION OF THE INCREASE IN THE COLLECTION OF GENERATION CHARGES AND EXTENDING DISCONNECTION NOTICES TO THE CONSUMERS FOR THE WHOLE PROVINCE OF PANGASINAN

WHEREAS, the recently increased power rate implementation by electric companies has hurt most the hard-up consumers and bear the brunt of the new hike;

WHEREAS, there are reported complaints from subscribers of electric companies regarding the increase in the power generation charge as reflected in their electric bills;

WHEREAS, the Sangguniang Panlalawigan is appealing for the suspension of the implementation of the increase in the collection of generation charge in order to unleash the burden of users;

WHEREAS, it is also the request of the Sangguniang Panlalawigan to extend the issuance of disconnection notices to consumers with outstanding power bills especially low-income earners;

WHEREAS, it is the earnest desire of the Sangguniang Panlalawigan to assist their constituents in their economic plight and financial woes particularly on utility bills and services especially during this time of public health crisis;




