PROVINCIAL RESOLUTION NO. 623-2021

INVITING THE SOCIAL SECURITY SYSTEM (SSS) BRANCH MANAGERS IN THE PROVINCE OF PANGASINAN TO A QUESTION HOUR OF THE SANGGUNIANG PANLALAWIGAN ON ITS JULY 26, 2021 REGULAR (PHYSICAL) SESSION TO APPRISE THE BODY ON THE PLANS AND PROGRAMS BEING IMPLEMENTED BY THE AGENCY TO PROTECT ITS MEMBERS/BENEFICIARIES MORE PARTICULARLY IN ACCELERATING THE PROCESSING OF THEIR DOCUMENTS

WHEREAS, the Social Security System (SSS) which is considered as one of the frontline services of the national government is mandated to provide a social security protection to workers in the private sector, wage earners as well as self-employed persons;

WHEREAS, the SSS provides protection to members and their families against the hazards of disability, sickness, maternity, old age, death and other contingencies resulting in loss of income or financial burden;

WHEREAS, the Province of Pangasinan which comprises 44 municipalities and 3 cities is being served by the SSS with four (4) branch offices and other service and representative offices;

WHEREAS, the SSS respective offices are rendering service to hundreds of clients every working day coming from the different parts of the Province, and the people are sometimes queueing in long lines and waiting for some time for their requests for claims and other documents to be processed;

WHEREAS, it is the aim of the Provincial Government to improve the welfare and needed services of the people especially for those who are much more vulnerable to COVID-19 like the old and immucompromised in terms of saving time and resources in going to and from the branch/service/representative offices of the SSS;

WHEREFORE, on motion of SP Member Rosary Gracia P. Perez-Tababa, duly seconded, it was –


