**PROVINCIAL RESOLUTION NO. 627-2020**

**AUTHORIZING THE PROVINCIAL ACCOUNTING OFFICE AND THE PROVINCIAL TREASURY OFFICE TO CREDIT TO THE EXISTING LIVELIHOOD TRUST FUND ACCOUNT 401(4)A ALL LOAN REPAYMENTS, INCLUDING INTEREST EARNED, UNDER THE PROVINCIAL LIVELIHOOD ASSISTANCE PROGRAM FUNDED THROUGH ANNUAL ALLOCATION FROM THE DEVELOPMENT FUND WITH ACCOUNT CODE NO. 8915**

**WHEREAS**, the Provincial Government of Pangasinan, through the Provincial Population Cooperative and Livelihood Development Office (PPCLDO), has been implementing the Provincial Livelihood Assistance Program (PLAP);

**WHEREAS**, the Provincial Livelihood Assistance Program is one of the priority development programs of Governor Amado I. Espino III;

**WHEREAS**, the said program provides credit assistance to cooperatives, community-based organizations and individual entrepreneurs as working capital for livelihood projects and additional capital for the expansion of business operations;

**WHEREAS**, the Provincial Livelihood Assistance Program is funded through annual allocation from the Development Fund (Account Code No. 8915) and existing trust funds specifically and exclusively for loans for livelihood projects;

**WHEREAS**, to ensure the sustainability of the Provincial Livelihood Assistance Program and to further increase its coverage to assist more viable community-based groups, micro, small and medium enterprises and cooperatives, all loan repayments from the annual allocation with Account Code No. 8915 shall be credited to the existing livelihood trust fund Account 401(4)A;

**WHEREAS**, there is a need to authorize the Provincial Accounting Office and the Provincial Treasury Office to credit to the existing livelihood trust fund Account 401(4)A all loan repayments, including interest earned, under the Provincial Livelihood Assistance Program funded through the annual allocation from the Development Fund with Account Code No. 8915;
