RESOLUTION NO. 630-2020

DECLARING THE SUPPLEMENTAL BUDGET NO. 1 FOR CALENDAR YEAR 2020 OF THE CITY OF ALAMINOS, PANGASINAN INVOLVING A TOTAL APPROPRIATION OF P77,901,169.61 OPERATIVE IN ITS ENTIRETY

WHEREAS, pursuant to R.A. No. 7160, otherwise known as the Local Government Code of 1991, the Sangguniang Panlalawigan of Pangasinan as a legislative body of the Province is empowered to review ordinances authorizing annual or supplemental appropriations of component cities and municipalities in the manner prescribed by law;

WHEREAS, the Sangguniang Panlungsod of Alaminos, Pangasinan submitted its Supplemental Budget No. 1 for Calendar Year 2020 involving total appropriations of **P77,901,169.61** which was approved on March 3, 2020 through Appropriation Ordinance No. 2020-01 and approved by the City Mayor on on March 19, 2020;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Local Finance Committee pursuant to Section 316 of the Local Government Code of 1991, have conducted preliminary review and study on said budget with the following findings:

1. The funding source for the subject Supplemental Budget were determined in accordance with Section 321 of RA 7160 and Article 417 (a) of its IRR, as amended by Administrative Order No. 47 dated April 12, 1993;
2. The full implementation of the First Tranche Compensation Adjustment for municipal officials and employees shall be subject to the provisions of Local Budget Circular No. 121 of the Department of Budget and Management dated January 24, 2020;

3. All programs, projects and activities shall be in accordance with the approved Local Development Plan and FY 2020 Supplemental Investment Program of the city formulated pursuant to DILG-NEDA-DBM Joint Memorandum Circular No. 1, S-2007 dated 08 March 2007;
4. The items funded out of the Local Disaster Risk Reduction and Management Fund shall be in accordance with RA No. 10121 known as the Philippine Disaster Risk Reduction and Management Act of 2010 and its IRR and the DBM-NDRRM-DILG Joint Memorandum Circular No. 2013-1 dated March 25, 2013;
5. The grant of Gratuity Pay to Job Order Workers in the Government Service shall be in accordance to Administrative Order No. 20 dated January 10, 2020;
6. All procurements to be undertaken shall be subject to the pertinent provisions of RA No. 9184 (The Government Procurement Reform Act) and its revised Implementing Rules and Regulations;
7. The purchase of motor vehicle/s shall be in accordance with the provisions of Administrative Order No. 14 dated December 10, 2018, and its implementing guidelines under Budget Circular No. 2019-2 dated March 4, 2019 amending Administrative Order No. 15 dated May 25, 2011, and Budget Circular No. 2017-1 dated April 26, 2017 amending Budget Circular No. 2016-5 dated August 22, 2016;
8. The appropriation for Performance Based Bonus Calendar Year 2018 shall be subject to Section 350 of RA 7160; *and*
9. The grant of Performance Based Bonus for Calendar Year 2019 should be in accordance with the provisions of DILG-DBM Joint Memorandum Circular No. 2019-01 dated November 21, 2019.

WHEREAS, the Sangguniang Panlalawigan, after final evaluation, finds the same in order provided that the findings shall be complied with by the city;
