#### RESOLUTION NO. 632-2020

APPROVING SB RESOLUTION NO. 03, S-2020 OF THE SANGGUNIANG BAYAN OF BANI, PANGASINAN, ENTITLED "APPROVING THE ANNUAL INVESTMENT PROGRAM OF BANI. PANGASINAN FOR FISCAL YEAR 2020 FUNDED BY THE GENERAL FUND AND MUNICIPAL DEVELOPMENT FUND (MDF)"

WHEREAS, the Sangguniang Bayan of Bani, Pangasinan submitted its SB Resolution No. 03, Series of 2020 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Provincial Planning and Development Officer, have conducted initial review and study on said resolution and found out that the same is in consonance to Sections 106, 109, 114 of RA 7160. The Local Development Council of Bani, Pangasinan had identified and prioritized programs and projects in their Annual Investment Program for CY 2020. This was endorsed by the Local Development Council to the Sangguniang Bayan thru MDC Resolution No. 2019-03 dated October 1, 2019 and was favorably acted upon by the Sangguniang Bayan on January 28, 2020 thru SB Resolution No. 03, S-2020;

WHEREAS, the Annual Investment Program of the municipality is in accordance with the Budget Operations Manual (BOM) for Local Government Units, 2016 Edition and in pursuance to DILG-NEDA-DBM-DOF Joint Memorandum Circular (JMC) No. 1, S-2007 dated March 8, 2007 and DBM-CCC-DILG JMC No. 2014-01 dated August 7, 2014, as amended by DBM-CCC-DILG JMC No. 2015-01 dated July 23, 2015 as to format and content. The AIP of Bani, Pangasinan was formulated following the prescribed AIP Summary Form, and covers: a) all the regular budgetary requirements for

the operation of the different offices broken down into: Personal Services (PS), Maintenance and Other Operating Expenses (MOOE) and Capital Outlay, b) the priority development programs/projects of the LGU including those to be funded by the 20% development fund, c) Disaster Risk Reduction (DRR) Programs/Projects/Activities, d) Local Climate Change Action Plan, e) Peace and Order Plan, f) Local Nutrition Action Plan and g) activities in pursuance of the objectives of GAD, Local Council for the Protection of Children, Senior Citizens, and Persons with Disabilities of the LGU and Local Culture and the Arts:

WHEREAS, the proposed AIP of Bani for CY 2020 has an investment requirement of P181,279,826.61. Funding support for the implementation of the said AIP is embodied in their 2020 proposed Annual Budget which was passed and approved by their Sangguniang Bayan on March 17, 2020 through Appropriation Ordinance No. 01, S-2020;

WHEREAS, this AIP is in accordance with Section 287 of RA 7160. Twenty percent (20%) of the LGUs IRA (P156,993,083.00) which is equivalent to P31,398,616.60 is allocated for development projects. It is respectfully suggested that the Rehabilitation of Children's Playground Phase I (P2,000,000.00) and the Rehabilitation of Sports Facilities (P500,000.00) to be funded by Development Fund may be substituted with other projects in the AIP CY 2020 that have more impact on the socio-economic development of the LGU as per DILG-DBM JMC No. 2017-1 dated February 22, 2017;

WHEREAS, the attached Disaster Risk Reduction and Management Plan in preparation for and to mitigate the impact of disasters to be funded by the 5% LDRRM Fund in the amount of P8,814,904.15) is in conformity to Section 21 of RA 10121. The programs/projects/activities to be funded by 70% of the 5% LDDRM Fund in the amount of P6,170,432.90 were based on NDRMMC, DBM & DILG Joint Memorandum Circular No. 2013-1 dated March 25, 2013 (Allocation and Utilization of the Local Disaster Risk Reduction and Management Fund). The DRRM Plan was reviewed and was issued certification by the Office of Civil Defense (OCD) on November 21, 2019 as per Local Budget Memorandum No. 77 dated May 15, 2018;

**WHEREAS**, the LGU of Bani had also identified programs, projects and activities responsive to Climate Change and tagged its corresponding expenditures in their AIP. This is in pursuance to DBM-CCC-DILG Joint Memorandum Circular No. 2015-01 dated July 23, 2015;

WHEREAS, the Gender and Development Programs, Projects and Activities (GAD-PPAs) attached were reviewed by the Department of Interior and Local Government (DILG) Provincial Office and were found to be fully compliant in form and in contents with the provisions of the DBM, PCW, DILG & NEDA Joint Memorandum Circular No. 2016-01 entitled "Amendments to JMC 2013-01 or the Guidelines on the Localization of Magna Carta of Women";
