#### **RESOLUTION NO. 634-2020**

DECLARING ORDINANCE NO. 06, S-2020 OF THE SANGGUNIANG INFANTA, PANGASINAN, **ENTITLED** ORDINANCE PROHIBITING ANY PERSON FROM COMMITTING ANY ACT WHICH CAUSES STIGMA, DISGRACE, SHAME, **HUMILIATION.** HARASSMENT. OR **OTHERWISE** DISCRIMINATING AGAINST A PERSON INFECTED, UNDER MONITORING **INVESTIGATION** OR DUE TO CORONAVIRUS DISEASE 2019 (COVID-19) INCLUDING PUBLIC AND PRIVATE DOCTORS, NURSES, HEALTH WORKERS, EMERGENCY PERSONNEL AND VOLUNTEERS, WORKERS WHO ARE ASSIGNED TO HOSPITALS OR OTHER CENTERS WHERE THESE PERSONS ARE BEING TREATED AND IMPOSING THE APPROPRIATE PENALTIES THEREIN" AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIANG **BAYAN TO ENACT** 

WHEREAS, the Sangguniang Bayan of Infanta, Pangasinan submitted its Ordinance No. 06, Series of 2020 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Provincial Legal Officer, have conducted initial review and study on said ordinance and found out that the same was enacted pursuant to Section 447 (a) (1), (5) (xii) of RA 7160; Section 5, General Provisions of the Omnibus Guidelines on the Implementation of Community Quarantine in the Philippines by the Inter-Agency Task Force for the Management of Emerging Infections Diseases:

**WHEREAS**, subject ordinance shall take effect after the Sanggunian shall have complied with the requirements of posting and publication pursuant to Sections 59 and 511 of RA 7160;

**WHEREFORE**, in view of the foregoing, on motion of SP Members Donabel N. Fontelera and Margielou Orange D. Humilde, Jr. and co-sponsored by SP Members Sheila Marie S. Perez-Galicia, Jerome Vic O. Espino and Jose G. Peralta, Jr., duly seconded, it was –

**RESOLVED**, by the Sangguniang Panlalawigan in session assembled, to declare Ordinance No. 06, S-2020 of the Sangguniang Bayan of **Infanta**, Pangasinan, entitled "An Ordinance prohibiting any person from committing any act which causes stigma, disgrace, shame, humiliation, harassment, or otherwise discriminating against a person infected, under monitoring or investigation due to the Coronavirus Disease 2019 (COVID-19) including public and private doctors, nurses, health workers, emergency personnel and volunteers, service workers who are assigned to hospitals or other centers where these persons are being treated and imposing the appropriate penalties therein" as within the conferred powers of the Sangguniang Bayan to enact;

**RESOLVED FURTHER**, that a copy of this resolution be furnished the Office of the Sangguniang Bayan of Infanta, Pangasinan, for its information and guidance.
