DECLARING ORDINANCE NO. 2021-13 OF THE SANGGUNIANG PANLUNGSOD OF ALAMINOS, PANGASINAN, ENTITLED "AN ORDINANCE AMENDING SECTION 3 OF ARTICLE 1, SECTION 3 OF ARTICLE XI, AND SECTION 4 OF ARTICLE XXV OF ORDINANCE NO. 2005-22, OTHERWISE KNOWN AS THE "COMPREHENSIVE TRANSPORTATION AND TRAFFIC ORDINANCE OF THE CITY OF ALAMINOS" AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIANG PANLUNGSOD TO ENACT
