DECLARING RESOLUTION 151, S-2020 OF THE **SANGGUNIANG BAYAN** OF BINMALEY, PANGASINAN. ENTITLED "GRANTING SPECIAL RISK ALLOWANCE TO PUBLIC HEALTH WORKERS DURING THE PERIOD OF ENHANCED COMMUNITY QUARANTINE RELATIVE TO COVID-19 OUTBREAK" AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIANG BAYAN TO ENACT

WHEREAS, the Sangguniang Bayan of Binmaley, Pangasinan submitted its Resolution No. 151, Series of 2020 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Provincial Legal Officer and the Local Finance Committee, have conducted initial review and study on said resolution and found out that the same was enacted pursuant to Section 4 (d) of RA No. 11469 or the "Bayanihan To Heal As One Act"; Section 1 of Administrative Order No. 28 dated April 6, 2020; Department of Budget and Management Circular No. 2020-2 (Grant of COVID-19 Special Risk Allowance);
