WHEREAS, the Local Development Council of Alcala, Pangasinan has formulated an endorsed the municipality's Supplemental Investment Program No. 2 for CY 2021 which was endorsed to the Sangguniang Bayan for approval through MDC Executive Committee Resolution No. 2021-02 dated on June 1, 2021;

**WHEREAS,** said Supplemental AIP with an investment requirement amounting to PHP1,414,905.14 covers fund augmentation for the personal services, maintenance and other operating expenses, and capital outlay of the executive department;
