**PROVINCIAL RESOLUTION NO. 640-2021**

**INVITING THE PROVINCIAL HEALTH OFFICER, PROVINCIAL DISASTER RISK REDUCTION AND MANAGEMENT OFFICER, AND PROVINCIAL DIRECTOR OF THE PANGASINAN POLICE PROVINCIAL OFFICE TO A QUESTION HOUR OF THE SANGGUNIANG PANLALAWIGAN DURING ITS AUGUST 2, 2021 REGULAR (PHYSICAL) SESSION TO UPDATE THE BODY ON THE SITUATION OF COVID-19 DELTA VARIANT IN THE PROVINCE OF PANGASINAN AND THE PREPARATIONS BEING UNDERTAKEN TO COMBAT THE SAME**

**WHEREAS**, the Department of Health has already confirmed the detection of local cases of the COVID-19 Delta variant in some parts of the country;

**WHEREAS**, the Sangguniang Panlalawigan expresses grave concern over the matter considering that COVID-19 Delta variant is highly transmissible;

**WHEREAS**, the Province of Pangasinan through the concerned authorities should double its efforts and enhance COVID-19 responses in areas where there are increases and clusters of COVID-19 cases;

**WHEREAS**, the Sangguniang Panlalawigan would like to hear directly from the Provincial Inter-Agency Task Force the situation of the COVID-19 Delta variant in the Province and the ongoing measures and approaches being undertaken to fight the same;

**WHEREAS**, the Sangguniang Panlalawigan, in collaboration with the Executive Branch particularly the Provincial Inter-Agency Task Force, will continue to look for ways and means to enact and pass legislative measures to combat COVID-19 particularly the new variant;



**NOW, THEREFORE**, on motion of SP Member Jeremy Agerico B. Rosario, duly seconded, it was –


