APPROVING MUNICIPAL RESOLUTION NO. 2020-133 OF THE SANGGUNIANG BAYAN OF ALCALA, PANGASINAN, ENTITLED “APPROVING THE SUPPLEMENTAL ANNUAL INVESTMENT PROGRAM NO. 02 FOR CALENDAR YEAR 2020 OF THE MUNICIPALITY OF ALCALA, PANGASINAN”

WHEREAS, the Sangguniang Bayan of Alcala, Pangasinan submitted its Municipal Resolution No. 2020-133 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Provincial Planning and Development Officer, have conducted initial review and study on said resolution and found out that the Local Development Council of Alcala, Pangasinan has identified programs/projects/activities to address emergency response measures to COVID-19 pandemic. This is embodied in the municipality’s Supplemental Investment Program No. 02 which was endorsed through MDC Resolution No. 2020-01 dated April 13, 2020 to the Sangguniang Bayan for approval. This was approved by their Sangguniang Bayan through Resolution No. 2020-133 dated April 14, 2020. This is in pursuance to Sections 106, 109, and 114 of RA 7160;

WHEREAS, the Supplemental Investment Program No. 02 has an investment requirement amounting to P10,855,717.00 which will be funded from Bayanihan Grant to Cities and Municipalities (BGCM) under RA No. 11469 (The Bayanihan To Heal As One Act);
