**APPROVING RESOLUTION NO. 29, S-2019 OF THE SANGGUNIANG BAYAN OF VILLASIS, PANGASINAN, ENTITLED “APPROVING THE ANNUAL INVESTMENT PROGRAM (AIP) FOR FISCAL YEAR 2020 AND OTHER ACTIVITIES RELATED TO THE ANNUAL BUDGET IN THE AMOUNT OF TWO HUNDRED TWENTY FOUR MILLION THIRTY SIX THOUSAND SEVEN HUNDRED PESOS (P224,036,700.00) AND ASSISTANCE TO MUNICIPALITIES (AM) AND LGSF – OTHER FINANCIAL ASSISTANCE TO LGU FROM NATIONAL GOVERNMENT OF THE MUNICIPALITY OF VILLASIS, PANGASINAN”**

**WHEREAS**, the Sangguniang Bayan of Villasis, Pangasinan submitted its Resolution No. 29, Series of 2019 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

**WHEREAS**, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Provincial Planning and Development Officer, have conducted initial review and study on said resolution and found out that the Local Development Council of Villasis, Pangasinan has formulated the municipality’s Annual Investment Program for CY 2020 and endorsed thru MDC Resolution No. 03-2019 dated August 20, 2019 to the Sangguniang Bayan for approval. This was subsequently approved by their Sangguniang Bayan thru Resolution No. 29, S-2019 dated September 30, 2019. This is in consonance to Sections 106, 109 and 114 of RA 7160;

**WHEREAS**, the Annual Investment Program of the municipality is in accordance with the Budget Operations Manual (BOM) for Local Government Units, 2016 Edition and in pursuance to DILG-NEDA-DBM-DOF Joint Memorandum Circular (JMC) No. 1, S-2007 dated March 8, 2007 and DBM-CCC-DILG JMC No. 2014-01 dated August 7, 2014, as amended by DBM-CCC-DILG JMC No. 2015-01 dated July 23, 2015 as to format and content. The AIP of Villasis, Pangasinan was formulated following the prescribed AIP Summary Form categorized into general public, social, economic and other service sectors and covers: a) all the regular budgetary requirements for the operation of the different municipal offices broken down into: Personal Services (PS), Maintenance and Other Operating Expenses (MOOE) and Capital Outlay, b) the priority development programs/projects of the LGU including those to be funded by the 20% development fund, c) Disaster Risk Reduction Management Programs/Projects/Activities of the municipality. It also includes the following: 1) Gender and Development Plan, Peace and Order Plan, Local Climate Change Action Plan, Nutrition Action Plan, Annual Cultural Development Plan and 2) list of programs/projects for the Local Council for the Protection of Children, Senior Citizens and Persons with Disabilities and programs/projects to combat HIV-AIDS;

**WHEREAS**, the AIP has a total investment requirement amounting to P265,036,700.00. Of this, P224,036,700.00 will be funded from the municipality's proposed 2020 Annual Budget which was passed and approved by their Sangguniang Bayan on September 30, 2019 through Appropriation Ordinance No. 02 CY 2019 while the remaining amount of P41,000,000.00 will be sourced from the national government agencies under the Assistance to Municipalities Program and LGSF – Other Financial Assistance to LGUs;

**WHEREAS**, more than twenty percent (20.16%) of the municipality's IRA (P163,715,700.00) for CY 2020 which is equivalent to P23,000,000.00 is allocated for development projects. This is in accordance with Section 287 of RA 7160;

**WHEREAS**, the identified development programs/projects to be funded by the 20% of IRA were based on the DILG-DBM Joint Memorandum Circular No. 2017-1, dated February 22, 2017 entitled "Updated Guidelines on the Appropriation and Utilization of the 20% of the Annual Internal Revenue Allotment (IRA) for Development Projects";

**WHEREAS**, the Gender and Development Plan of the municipality was already reviewed by the Department of Interior and Local Government (DILG) and found to be fully compliant in form and contents with the provisions of the Joint Memorandum Circular No. 2016-01: Amendments to JMC 2013-01 re: Guidelines on the Localization of Magna Carta of Women as per attached Certificate of Review and Endorsement of the DILG issued on March 21, 2019;
