RESOLUTION NO. 665-2019

DECLARING MUNICIPAL ORDINANCE NO. 2019-01 OF THE SANGGUNIANG BAYAN OF BALUNGAO, PANGASINAN, ENTITLED "AN ORDINANCE CREATING THE POSITIONS OF LOCAL LEGISLATIVE STAFF EMPLOYEE II, LOCAL LEGISLATIVE STAFF ASSISTANT II, LOCAL LEGISLATIVE STAFF ASSISTANT III, LOCAL LEGISLATIVE STAFF OFFICER III, WITH SALARY GRADES 4, 8, 10 AND 16, RESPECTIVELY, AND APPROPRIATING FUNDS THEREFOR" AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIANG BAYAN TO ENACT

WHEREAS, the Sangguniang Bayan of Balungao, Pangasinan submitted its Municipal Ordinance No. 2019-01 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Local Finance Committee, have conducted initial review and study on said municipal ordinance and found out that the same was enacted pursuant to Section 76 and Section 447 (a) (1) (viii) of RA 7160;

WHEREAS, Section 4 of the municipal ordinance involves appropriation of salaries and other benefits of the new position. This section should be incorporated in an appropriation ordinance;


WHEREAS, the grocery allowance of P12,000.00 shall not be allowed for lack of legal basis;
