RESOLUTION NO. 665-2021

DECLARING ORDINANCE NO. 2021-07 OF THE SANGGUNIANG PANLUNGSOD OF ALAMINOS, PANGASINAN, ENTITLED "AN ORDINANCE RECLASSIFYING A PORTION OF LAND OWNED BY SHERYL BAUTISTA LATORRE CONTAINING AN AREA OF ONE THOUSAND SQUARE METERS (1,000 SQ.M.) SITUATED AT BRGY. SAN VICENTE, THIS CITY, FROM AGRICULTURAL USE TO COMMERCIAL USE PRIMARILY FOR THE ESTABLISHMENT OF A GASOLINE STATION" AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIANG PANLUNGSOD TO ENACT

WHEREAS, the Sangguniang Panlungsod of Alaminos, Pangasinan submitted its City Ordinance No. 2021-07 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Legal Officer, Provincial Planning and Development Coordinator, Provincial Agrarian Reform Program Officer II, and Regional Officer of the Housing and Land Use Regulatory Board have conducted initial review and study on said municipal ordinance and found out that the same was enacted pursuant to Sections 20 and 458 (a) (2) (viii) of R.A. No. 7160;

WHEREAS, the City of Alaminos has an existing Zoning Ordinance implementing its Comprehensive Land Use Plan CY 2017-2026, wherein said parcel of land is classified as agricultural under the agricultural zone;

WHEREAS, however, Clearance for Reclassification (Certifications) from the Department of Agrarian Reform and from the Department of Agriculture shall be secured and submitted to the Sangguniang Panlalawigan before subject ordinance will be effected;

WHEREFORE, in view of the foregoing, on motion of SP Members Donabel N. Fontelera and Margielou Orange D. Humilde-Verzosa and co-sponsored by SP Members Sheila Marie S. Perez-Galicia, Jerome Vic O. Espino and Jeanne Jinky C. Zaplan, duly seconded, it was –

RESOLVED, by the Sangguniang Panlalawigan in session assembled, to declare Municipal Ordinance No. 2021-07 of the Sangguniang Panlungsod of Alaminos, Pangasinan, entitled "An Ordinance Reclassifying a Portion of Land Owned by Sheryl Bautista Latorre Containing an Area of One Thousand Square Meters (1,000 sq. m.) Situated at Brgy. San Vicente, this City, from Agricultural Use to Commercial Use Primarily for the Establishment of a Gasoline Station" as within the conferred powers of the Sangguniang Panlungsod to enact;

RESOLVED FURTHER, that a copy of this resolution be furnished the Office of the Sangguniang Panlungsod of Alaminos, Pangasinan, for its information and guidance.
