**APPROVING RESOLUTION NO. 2019-098 OF THE SANGGUNIANG BAYAN OF BALUNGAO, PANGASINAN, ENTITLED “APPROVING THE SUPPLEMENTAL ANNUAL INVESTMENT PROGRAM (SAIP) NO. 3 FOR THE CALENDAR YEAR 2019 OF THE MUNICIPALITY OF BALUNGAO, PANGASINAN”**

**WHEREAS**, the Sangguniang Bayan of Balungao, Pangasinan submitted its Resolution No. 2019-098 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

**WHEREAS**, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Provincial Planning and Development Officer, have conducted initial review and study on said resolution and found out that the Local Development Council of Balungao, Pangasinan has formulated the municipality’s Supplemental Annual Investment Program No. 3 for Calendar Year 2019 and endorsed to the Sangguniang Bayan for approval thru MDC Resolution No. 2019-05 dated September 2, 2019. This was approved by their Sangguniang Bayan thru Resolution No. 2019-098 dated October 9, 2019. This is in pursuance to Sections 106, 109 and 114 of RA 7160;

**WHEREAS**, the Supplemental Annual Investment Program No. 3 of the municipality with an investment requirement of P11,353,974.53 covers the fund augmentation for the implementation of existing development project, disaster risk reduction management programs and personal services, and MOOE of some municipal offices;
