RESOLUTION NO. 667-2021

DECLARING ORDINANCE NO. 2021-17 OF THE SANGGUNIANG PANLUNGSOD OF ALAMINOS, PANGASINAN, ENTITLED “AN ORDINANCE PROHIBITING THE DISCRIMINATION AGAINST PERSONS WHO ARE DECLARED CONFIRMED, SUSPECT, PROBABLE, AND RECOVERED CASES OF COVID-19, REPATRIATED FILIPINOS, HEALTHCARE WORKERS, RESPONDERS, AND SERVICE WORKERS, PROVIDING PENALTIES FOR VIOLATION THEREOF” AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIANG PANLUNGSOD TO ENACT

WHEREAS, the Sangguniang Panlungsod of Alaminos, Pangasinan submitted its Ordinance No. 2021-17 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Legal Officer, have conducted initial review and study on said ordinance and found out that the same is in consonance to Section 458 (a) (1) (iii), (5) (v) and (xii) of R.A. No. 7160;

WHEREAS, subject ordinance shall take effect after the requirements of posting and publication pursuant to Sections 59 (c) and 511 (a) of RA 7160 are complied with;


