DECLARING ORDINANCE NO. 2021-18 OF THE SANGGUNIANG PANLUNGSOD OF ALAMINOS, PANGASINAN, ENTITLED “AN ORDINANCE UPDATING CITY ORDINANCE NO. 02-2003, ENTITLED: ‘AN ORDINANCE REGULATING THE OPERATION OF PIGGERY BUSINESS IN THE CITY OF ALAMINOS, PANGASINAN AND PROVIDING PENALTIES FOR VIOLATION THEREOF AND FOR OTHER PURPOSES” AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIANG PANLUNGSOD TO ENACT


