WHEREAS, the Sangguniang Bayan of Balungao, Pangasinan submitted its Resolution No. , Series of 2017 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Provincial Planning and Development Officer, have conducted initial review and study on said resolution and found out that the Local Development Council of Balungao, Pangasinan has formulated the municipality’s Supplemental Annual Investment Program No. 7 which was endorsed thru MDC Resolution No. 9, S-2017 dated November 29, 2017 to the Sangguniang Bayan for approval. The Sangguniang Bayan approved said MDC Resolution through Resolution No. 2017-216-142 dated December 13, 2017. This is in pursuance to Sections 106, 109 and 114 of RA 7160;

WHEREAS, the Supplemental Investment Program of the municipality pertains to the procurement of rescue vehicle which will be funded from the Performance Challenge Fund amounting to P2M. The identified project is a new project and was not included in the 2017 approved Annual and Supplemental Investment Programs of the municipality;


WHEREAS, the Sangguniang Panlalawigan, after final evaluation, finds the subject resolution in order;
