APPROVING RESOLUTION NO. 19-59 OF THE SANGGUNIANG BAYAN OF STA. MARIA, PANGASINAN, ENTITLED "APPROVING THE MUNICIPAL DEVELOPMENT COUNCIL RESOLUTION NO. 2019-01 EMBODYING THE SUPPLEMENTAL ANNUAL INVESTMENT PROGRAM (SAIP) NO. 1 FOR FY 2019 OF THE MUNICIPALITY OF STA. MARIA, PANGASINAN"

WHEREAS, the Sangguniang Bayan of Sta. Maria, Pangasinan submitted its Resolution No. 19-59 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Provincial Planning and Development Officer, have conducted initial review and study on said resolution and found out that the Local Development Council of Sta. Maria, Pangasinan has formulated the municipality's Supplemental Investment Program No. 1 for FY 2019 and endorsed to the Sangguniang Bayan for approval thru MDC Resolution No. 2019-01 dated September 10, 2019. The Sangguniang Bayan approved the Supplemental Investment Program No. 1 on September 25, 2019 thru Resolution No. 19-59. This is in pursuance to Sections 106, 109 and 114 of RA 7160;

WHEREAS, the Supplemental Investment Program No. 1 of the municipality covers fund augmentation for the personal services, maintenance and other operating expenses of offices and implementation of development projects to be funded by LGSF-Financial Assistance to LGUs 2019;

WHEREAS, the said Supplemental Investment Program No. 1 of Sta. Maria, Pangasinan has a total investment requirement amounting to P70,123,916.04. Of this, P5,123,916.04 will be funded by their Supplemental Budget No. 1 enacted thru Appropriation Ordinance No. 19-01 dated September 25, 2019 while the remaining amount of P65,000,000.00 will be funded by national government agency under the LGSF-FA to LGUs;


WHEREAS, the Sangguniang Panlalawigan, after final evaluation, finds the subject resolution in order;
