#### CERTIFICATION

TO WHOM IT MAY CONCERN:

THIS IS TO CERTIFY that at the regular session duly constituted of the Sangguniang Panlalawigan, Province of Pangasinan, held on July 3, 1998 at Lingayen, Pangasinan, the following provincial ordinance was approved:

#### PROVINCIAL ORDINANCE NO. 68-98

AN ORDINANCE CREATING THE STANDING COMMITTEES OF THE SANGGUNIANG PANLALAWIGAN OF PANGASINAN FOR 1998-2001

Be it enacted by the Sangguniang Panlalawigan in session duly assembled that:

SECTION 1. Standing committees are hereby created by the Sangguniang Panlalawigan of Pangasinan for 1998-2001, composed of at least five (5) members, including the Chairman, Vice Chairman, and the automatic members drawn from the Sanggunian membership, and assigned to address specific area(s) of legislation; provided, however, that no member shall be Chairman or Vice Chairman of more than two (2) regular committees except those who are automatic members of said committees;

SECTION 2. Committees shall meet at the call of their respective Chairman or a majority of their members;

SECTION 3. A majority of the members of a committee shall constitute a quorum to do business. Unexplained absences in four (4) consecutive committee meeting shall operate to relinquish membership therein;

SECTION 4. Standing Committees shall remain operative during the term of the Sanggunian and serve

as a miniature legislative body whose membership and general jurisdiction are fixed and specified in the Sanggunian Rules;

SECTION 5. Unless otherwise provided, the following standing committees are hereby created for the specified purposes and shall exercise and discharge such functions and powers as thereby provided in the Rules of Procedure:

- 1. Blue Ribbon Committee
- 2. Committee on Rules and Privileges
- 3. Committee on Finance and Appropriations
- 4. Committee on Ways and Means
- 5. Committee on Agriculture, Food and Agrarian Reform
- Committee on Trade, Industry and Cooperatives
   Committee on Public Works and Infrastructure
- 8. Committee on Barangay Affairs
- 9. Committee on Youth and Sports Development
- 10. Committee on Women and Family Affairs
- 11. Committee on Education, Arts and Culture
- 12. Committee on Labor, Employment and Human Resource Development
- 13. Committee on Health and Sanitation
- 14. Committee on Environment, Energy, Natural Resources and Ecology
- 15. Committee on Social Welfare and Development
- 16. Committee on Tourism
- 17. Committee on Housing and Land Utilization
- 18. Committee on Laws and Ordinances
- 19. Committee on Peace and Order and Public Safety
- 20. Committee on Transportation and Communications
- 21. Committee on Justice and Human Rights

SECTION 6. REPEALING CLAUSE. - All ordinances, rules and regulations, or parts thereof, inconsistent with or in conflict with the provisions of this Ordinance, shall be deemed repealed or amended accordingly;

SECTION 7. EFFECTIVITY. This Ordinance shall take effect upon approval.
