#### **RESOLUTION NO. 68-2021**

APPROVING MUNICIPAL RESOLUTION NO. 208-2020 OF THE SANGGUNIANG BAYAN OF ANDA, PANGASINAN, ENTITLED "APPROVING THE SUPPLEMENTAL INVESTMENT PROGRAM (SIP) NO. 05, SERIES OF 2020 OF ANDA, PANGASINAN"

**WHEREAS**, the Sangguniang Bayan of Anda, Pangasinan submitted its Municipal Resolution No. 208-2020 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Provincial Planning and Development Officer, have conducted initial review and study on said resolution and found out that the same is in consonance to Sections 106, 109, 114 of RA 7160. The Local Development Council of Anda, Pangasinan had identified items in their Supplemental Investment Program No. 05 for CY 2020. This was endorsed to the Sangguniang Bayan for approval on December 2, 2020 by the Municipal Development Council through MDC Resolution No. 06, S-2020;

**WHEREAS**, the Supplemental Investment Program No. 05 of the municipality covers fund augmentation for the Personal Services (granting of Collective Negotiation Agreement Incentive to municipal officials and employees) and Capital Outlay of some municipal offices and implementation of development projects of the municipality;

WHEREAS, the proposed Supplemental Investment Program has an investment requirement of P3,865,000.00. Funding for the implementation of the same is embodied in their proposed Supplemental Budget No. 3, CY 2020, which was enacted by their Sangguniang Bayan through Appropriation Ordinance No. 04, Series of 2020 on December 7, 2020 and approved by the Municipal Mayor on December 16, 2020;
