RESOLUTION NO. 682-2020

DECLARING ORDINANCE NO. 2020-01 OF THE SANGGUNIANG BAYAN OF SISON, PANGASINAN, ENTITLED "AN ORDINANCE DECLARING EVERY LAST THURSDAY OF OCTOBER AS "BEGNAS" OF THE MUNICIPALITY OF SISON, PANGASINAN" AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIANG BAYAN TO ENACT

WHEREAS, the Sangguniang Bayan of Sison, Pangasinan submitted its Ordinance No. 2020-01 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Provincial Legal Officer, have conducted initial review and study on said ordinance and found out that the same was enacted pursuant to Republic Act No. 8731 or the Indigenous People's Right Act of 1997 and Sections 16 and 447 (a) (1) of RA 7160;

WHEREAS, subject ordinance shall take effect after compliance with the posting and publication requirements pursuant to Sections 59 (c) and 511 (a) of RA 7160;

WHEREFORE, in view of the foregoing, on motion of SP Members Rosary Gracia P. Perez-Tababa and Nicholi Jan Louie Q. Sison and co-sponsored by SP Members Sheila Marie S. Perez-Galicia, Jerome Vic O. Espino and Jose G. Peralta, Jr., duly seconded, it was –

RESOLVED, by the Sangguniang Panlalawigan in session assembled, to declare Ordinance No. 2020-01 of the Sangguniang Bayan of **Sison**, Pangasinan, entitled "An Ordinance declaring every last Thursday of October as "Begnas" of the Municipality of Sison, Pangasinan" as within the conferred powers of the Sangguniang Bayan to enact;
