APPROVING RESOLUTION NO. 68, S-2020 OF THE SANGGUNIANG BAYAN OF ASINGAN, PANGASINAN, ENTITLED “APPROVING THE MUNICIPAL DEVELOPMENT COUNCIL RESOLUTION NUMBER 3 WITH THE CY 2020 SUPPLEMENTAL ANNUAL INVESTMENT PROGRAM NUMBER 2 OF THE MUNICIPALITY OF ASINGAN, PANGASINAN”

WHEREAS, the Sangguniang Bayan of Asingan, Pangasinan submitted its Resolution No. 68, Series of 2020 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Provincial Planning and Development Officer, have conducted initial review and study on said resolution and found out that the Local Development Council of Asingan, Pangasinan had identified programs/projects in their Supplemental Annual Investment Program No. 2 for Calendar Year 2020. This was endorsed to the Sangguniang Bayan for approval thru MDC Resolution No. 3, S-2020 dated June 1, 2020 and was favorably acted upon by the Sangguniang Bayan on June 8, 2020 thru Resolution No. 68, S-2020;

WHEREAS, the Supplemental Investment Program No. 2 of the municipality has an investment requirement amounting to P17,809,737.59, covers the programs/projects to address the crisis brought by COVID-19 pandemic. This will be funded by the Bayanihan Grant to Cities/Municipalities which is supported by Supplemental Budget No. 2 (P12,919,833.00) and Unspent LDRRM Fund from 2015-2019 (P4,889,904.59) Trust Fund;
