APPROVING RESOLUTION NO. 256, S-2019 OF THE SANGGUNIANG BAYAN OF BINMALEY, PANGASINAN, ENTITLED "APPROVING MDC RESOLUTION NO. 6, SERIES OF 2019, REVISING THE 2019 ANNUAL INVESTMENT PROGRAM OF THE MUNICIPALITY OF BINMALEY, PANGASINAN"

**WHEREAS**, the Sangguniang Bayan of Binmaley, Pangasinan submitted its Resolution No. 256, Series of 2019 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Provincial Planning and Development Officer, have conducted initial review and study on said resolution and found out that the Local Development Council of Binmaley, Pangasinan has revised their Annual Investment Program for Calendar Year 2019 to include Barangay Camaley in the Renovation/Rehabilitation of Evacuation Center in Barangays Project, which was typographically overlooked in the printed copy of their final and approved 2019 AIP, as per Paragraphs 1 and 2 of MDC Resolution No. 6, S-2019. Said MDC Resolution was endorsed to the Sangguniang Bayan on October 8, 2019 and was favorably acted upon by the Sangguniang Bayan on October 14, 2019 thru SB Resolution No. 256, S-2019. This is in pursuance to Sections 106, 109 and 114 of RA 7160;

**WHEREAS**, the inclusion of additional barangay does not involve changes in the total project cost in the amount of P10,100,000.00 as well as in the total investment requirement of the AIP 2019 of the LGU of Binmaley in the amount of P227,081,515.48;
