**DECLARING ORDINANCE NO. 92, S-2020 OF THE SANGGUNIANG BAYAN OF SAN NICOLAS, PANGASINAN, ENTITLED “AN ORDINANCE WAIVING THE MARKET STALL RENTAL FEE FOR THE MONTH OF MARCH TO MAY 2020 IN THE MUNICIPALITY OF SAN NICOLAS, PANGASINAN” AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIANG BAYAN TO ENACT**

**WHEREAS**, the Sangguniang Bayan of San Nicolas, Pangasinan submitted its Ordinance No. 92, Series of 2020 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

**WHEREAS**, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Provincial Legal Officer, have conducted initial review and study on said ordinance and found out that the same was enacted pursuant to Section 192 of RA 7160 and Section 4 (2) of RA No. 11469, otherwise known as “Bayanihan to Heal as One Act”;

**WHEREAS**, subject ordinance shall take effect after the requirement of posting pursuant to Section 59 of RA 7160 is complied with;
