**RESOLUTION NO. 698-2017**

**DECLARING MUNICIPAL ORDINANCE NO. 10-2017 OF THE SANGGUNIANG BAYAN OF URBIZONDO, PANGASINAN, ENTITLED "AN ORDINANCE AMENDING MUNICIPAL ORDINANCE NO. 1-2015 "AN ORDINANCE PROHIBITING THE OPERATION OF MOTOR VEHICLE WITH MODIFIED MUFFLER WITHIN THE TERRITORIAL JURISDICTION OF THE MUNICIPALITY OF URBIZONDO, PANGASINAN AND PROVIDING PENALTIES FOR VIOLATION THEREOF" AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIANG BAYAN TO ENACT**

**WHEREAS**, the Sangguniang Bayan of Urbizondo, Pangasinan submitted its Municipal Ordinance No. 10-2017 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

**WHEREAS**, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Provincial Legal Officer, have conducted initial review and study on said municipal ordinance and found out that the same was enacted pursuant to Article 694 of the Civil Service Code of the Philippines; Section 447 (a) (1) (iii), (2) (vi) and (5) (v) of RA 7160 and Article IV (Accessories of Motor Vehicles), Section 34 of Republic Act No. 4136 (An Act to Compile the Laws Relative to Land Transportation and Traffic Rules, to Create a Land Transportation Commission and For Other Purposes);


