WHEREAS. pursuant to the pertinent provisions of the New Local Government Code, in the creation of new barangay, all the essential requirements therein are satisfactorily medit

WHEREAS, the residents and leaders therein are of the firm belief that the creation would hasten social, economic and political diplomats in the area and foster faster delivery of basic services;

WHEREFORE, in view of the foregoing, on motion of SP Member Diomicio C. Antiniw, spontaneously seconded, it was -

RESOLVED. FURTHER, to request the COMBLEC to schedule the holding of a plebiscite in this new barangay within forty five (45) from approval of this ordinance and for the COMELEC to duly inform this Body of the holding of such plebiscite for its information and guidance;

RESOLVED. FURTHERMORE, that the Provincial Assessor in coordination with other agencies, determine the official boundaries of this newly created barangay for the official record and for the information of all
